# APPLICATION PROCESS

## EXCELLENCE IN ENVIRONMENTAL PRACTICE

### KEY JUDGING CRITERIA

Nominations can be self-nominated or made on behalf of someone else.

Nominations are due **no later than 11:59pm (AEST) Friday 2 June, 2017.**

Nominees must be active participants in the commercial seafood industry and must have:

- Created or developed an item or a process that lessens the impact of the seafood industry (catching or processing) on the environment; or
- Created or developed an item or a process that enhances the ecological sustainability of the seafood industry; OR
- Taken sustained or significant action to improve the state of waterways and thus improve their ability to support natural fish populations; or
- Actively facilitated moves within the seafood industry towards sustainable environmental management with the promotion of these changes within the industry and to the broader community.

Please provide a brief overview of the nominee and address how the nominee has contributed significantly to protecting or rehabilitating fisheries environments and ecosystems; innovation; and/or minimising the industry's impact on the environment.
